Nicola De Sanctis

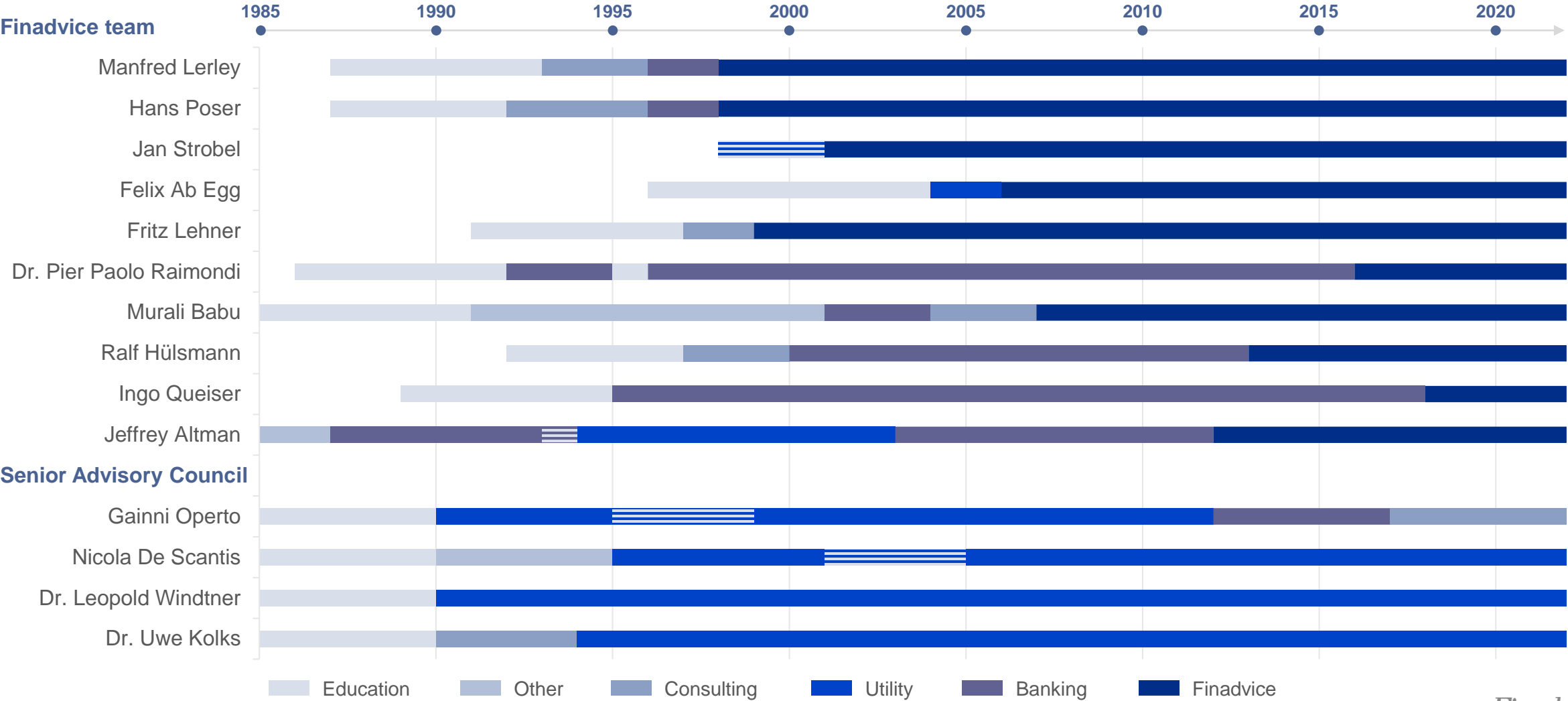
